

NOTICE OF ANNUAL MEETING OF SHAREHOLDERS

NOTICE IS HEREBY GIVEN that an annual meeting (the “**Meeting**”) of shareholders of Aecon Group Inc. (the “**Corporation**”) will be held at the Design Exchange, Toronto, Ontario, Canada, on June 29, 2017 at 11:00 a.m. (Eastern Daylight Time) for the following purposes:

- (i) to receive the annual financial statements of the Corporation for the financial year ended December 31, 2016 and the report of the auditors thereon;
- (ii) to elect directors of the Corporation;
- (iii) to consider and, if deemed advisable, approve the advisory resolution to accept the approach to executive compensation disclosed herein;
- (iv) to consider and, if deemed advisable, to pass with or without variation, an ordinary resolution in the form set forth in Appendix Two of this Management Information Circular, confirming a new by-law of the Corporation (“**By-law No. 2**” or “**Advance Notice By-law**”) adopting advance notice requirements for nominations of directors by shareholders;
- (v) to reappoint the auditors of the Corporation and to authorize the Board of Directors of the Corporation to fix their remuneration; and
- (vi) to transact such other business as may properly come before the Meeting or any adjournment thereof.

The directors of the Corporation have fixed the close of business on May 12, 2017 as the record date for the determination of the shareholders of the Corporation entitled to receive notice of and to vote at the Meeting.
